**Judging Schedule**

Novice B & A Standard and JWW classes will run together by jump heights with division B running before division A. Excellent B & A Standard and JWW will run together by jump height with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors. It is likely this event will draw a large spectator crowd. Bleacher sitting will be set up along at least one side of the rings. Please remember it is your responsibility as an exhibitor to conduct yourself in a manner consistent with that of a good sportsman.

**Walk through:** will begin as soon as the Judge has approved the course. This will be at approximately 9:00 am. Novice and Open: all heights will walk the course together. Excellent will be split according to the judge's instructions on the day of the show. Preferred dogs will walk with the appropriate jump height.

Judging will begin each day at 9:15 am. Check in will begin at 8:15 am. All dogs must either: be measured, or present a height card at check-in, or have previously sent a copy of the height card to the Trial Secretary. Measurement of dogs without height cards will be at approximately 8:30 – 9:00 am each day and throughout the day when Kera Holm is not otherwise occupied.

Dogs will be judged as follows: from the lowest number in each class to the highest number.  
The jump height will be: 24, 20, 16, 12, 8, 4

The class order will be:  
Standard Ring: Open, Excellent, Novice  
JWW Ring: Excellent, Open, Novice

**Ring Size and Surface**

The trial will be held outside on grass. Ring size will be 100 x 100.

### **Prizes and Awards**

Rosettes will be awarded 1<sup>st</sup> – 4<sup>th</sup> place in each jump height class to dogs with qualifying scores. Green Ribbons will be awarded to all dogs with qualifying scores. A Puli themed Fantasy Glass item will be given to the Highest Scoring Puli that qualifies in the Standard Class. In the case of a tie, the fastest yards per second will determine the winner. If there is no Puli qualifier in the Standard Class, the award will be given to the Highest Scoring Puli in the JWW class.

### **Course Familiarization/Warm-ups**

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. Only handlers entered in a class are allowed to walk the course during familiarization. No coaches/instructors are allowed unless they are entered in the class. A warm up area, consisting of a regulation agility jump, shall be provided for all exhibitors.

### **Notice to Exhibitors**

This event is open to all AKC registered dogs 12 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

Running orders will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible. If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.

Full refund for bitches in season before the Monday preceding the event. Full refund less 50% for bitches in season between Monday and Friday.

Exhibitors are responsible for complete, accurate, and legible information on their entry forms. Illegible or incomplete entries cannot be entered in the trial.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances ore repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Please be courteous and pick up after your dog.

Exhibitors while competing must wear proper, toe enclosed, footwear.

Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies vaccine is required in the State of California.
