**From Philadelphia (East):** Take the PA Turnpike (I-76) east to RT 222 (Exit 286). Take Rt 222 South to Rt 30. Take Rt 30 West. The hotel is on the left

**From Philadelphia Airport:** Take I-95 south to RT 322. Take RT 322 west to RT 41. Take RT 41 north to RT 30. Take RT 30 west. The hotel will be on the left.

**From Baltimore (South):** Take I-83 north to the RT 30 exit to York, PA. Take RT 30 east to the Lincoln Hwy exit (a continuation of RT 30). Turn left on Lincoln Highway and go southeast. The hotel will be on your right.

**From Harrisburg (North):** Take RT 283 east to RT 30. Take RT 30 east to the Lincoln Hwy. Exit (a continuation of RT 30). Turn left on Lincoln Hwy. and go southeast. The hotel will be on the right.

**From Pittsburgh (West):** Take the PA Turnpike (I-76) east to Exit 247, Harrisburg East. Take RT 283 east to Lancaster. RT 283 runs into RT 30 east. Go east on RT 30 to the Lincoln Hwy. exit (a continuation of RT 30). Turn left on Lincoln Hwy and go southeast. The hotel will be on the right.

**From New York:** Take the New Jersey Turnpike (1095) to the PA Turnpike (I-276 to I-76) east to RT 222 (Exit 285). Take RT 222 south to RT 30. Go east on RT 30 to the Lincoln Highway exit (a continuation of RT 30) Turn left on Lincoln Hwy and go southeast. The hotel will be on your right.
